1. An abstract of not more than 250 words should be emailed to: conference@saut.ac.tz (Paper or poster presentation)
2. Abstracts should be in one continuous paragraph and include up to 6 keywords, objectives, content and conclusion.
3. Abstracts should include the names of the author (s), affiliations, postal, email and telephone contacts, with the sub-theme indicated.
4. The full paper should be 3000 - 5000 words prepared in Times New Roman, size 12 font, spacing of 1.5 and in editable text format.
5. All references cited in the papers should be done as it is common in the discipline.

Abstracts and papers for languages can be submitted/presented either in English or Kiswahili (depending with discipline)

- Exemplary papers will be considered for publication as conference proceedings in a special issue of the SAUT Multi-Disciplinary Journal of Education.
